NOTICE

By this notice the Department of Agriculture informs the public about the proposal for the next:

REGULATION TO GOVERN THE AGRICULTURAL WAGE SUBSIDY PROGRAM ACCORDING TO THE PUERTO RICO INCENTIVES CODE, ACT 60-2019, AS AMENDED

The proposed regulation is presented under the Reorganization Plan No. 4 of July 26, 2010, known as the "Department of Agriculture Reorganization Plan", as amended, Act. No. 60 of July 1, 2019, known as the "Incentives Code of Puerto Rico", as amended, and Act. No. 38 of June 30, 2017, known as the "Government of Puerto Rico Uniform Administrative Procedure Act", as amended.

This Regulation will be available for public review in the Office of Legal Affairs of the Agency or through our web page <https://www.agricultura.pr/documentos>. We are located on No. 1309 Fernandez Juncos Ave., Stop 19 1/2, San Juan, Puerto Rico. Open to the public Monday through Friday from 7:30 am to 4:00 pm.

Any comment, recommendation or request for hearing accompanied by the grounds which justify the granting there of shall be submitted in writing to the Secretary of Agriculture within the next thirty (30) days counted from the date of publication, Address: Apartado 10163, San Juan, PR 00908-1163 or info@agricultura.pr.gov.

NOTE: This announcement is required by Act 38 of 2017, as amended, the Uniform Administrative Procedure Act of the Government of Puerto Rico, in Article # 12.001, Section 2.1, indicates the following:

Whenever the agency intends to adopt, amend or repeal a rule or regulation, it will publish a notice in Spanish and English in no less than one newspaper of general circulation in Puerto Rico, and in Spanish and English on the Internet. Provided, that if the adoption, amendment, or repeal of the rule or regulation affects a specific community of residents, the agency must publish the same notice in a regional newspaper that circulates in the area where said community is located, and it must also state an announcement on a local radio station with the highest audience or closest proximity to the affected community at least two (2) occasions at any time between 7:00 a.m. and 7:00 a.m. the night. The radio announcement must indicate the date the announcement was published in the newspaper. Both the radio announcement and the notice will contain a summary or brief explanation of the purposes of the proposed action, a quote from the legal adoption that authorizes said action, and the form, location, days and hours in which comments may be submitted by written or by email or request in writing an oral hearing on the proposed action with the grounds that in the opinion of the applicant make it necessary to grant said oral hearing and will indicate the physical place and the electronic address where the full text will be available to the public of the regulations to be adopted. Upon receiving comments by email, the agency will acknowledge receipt of them by email within two (2) business days of receipt. The notice published in the newspaper will also contain the electronic address of the page where the agency has chosen to publish the notice on the Web and the full text of the rule or regulation. Any notice regarding the proposed adoption of regulations that is published or intends to be published pursuant to the provisions of this Section, shall be exempt from the application of the provisions of Article 12.001 of Law 78-2011, as amended, known as the "Electoral Code of Puerto Rico for the XXI Century"
